Current members of this group include representatives from the NZ Police, the Ministry of Social Development, Health NZ | Te Whatu Ora, Kāinga Ora, Wellington City Mission and DCM.

To date, Council hasn't provided any grants to He Herenga Kura.

Our approach to managing and monitoring funding is set out in a relationship management framework. Through this framework, higher levels of monitoring are in place for organisations working with vulnerable client groups (including children and young people); this includes all grant funding to organisations doing social work and youth work. Organisation receiving more than \$250,000 per annum also fall in this higher monitoring category. Monitoring includes a Council Officer as relationship manager, formal scheduled meetings and regular reporting on agreed outcomes.

Please see our Contract Funding page which outlines provides more information about how we will monitor and report on the funding. The organisations listed in Question 9 would be subject to this high level of monitoring.

## Plans or programmes for suburbs (Q11):

We do not currently have specific plans to expand safety services in suburban areas, however our existing services with reach across the city continue. These include:



Your request has been considered under the Local Government Official Information and Meetings Act 1987 (LGOIMA).

I refer you to our <u>City Safety and Wellbeing Plan</u>, point 121:

Subject to resourcing capacity, we will take a proactive and balanced approach to bylaw compliance. This will involve:

- Strengthening coordination between enforcement teams, Police, and community
  partners to ensure a joined-up approach in responding to issues that arise in public
  spaces.
- Enhancing visibility and engagement with the public by ensuring officers and staff are well-equipped to educate, inform, and de-escalate situations where necessary before enforcement measures are required.
- Providing targeted responses to recurring challenges, such as unauthorised street trading, anti-social behaviour, and obstructions in high-traffic areas, through data-driven insights and ongoing monitoring.
- Building capacity among frontline staff by delivering training and guidance on how to apply the bylaw effectively.
- Regularly reviewing implementation to assess its effectiveness in addressing emerging challenges.

Urban Liaison Officers will be warranted to enforce Section 164 of the Local Government Act 2002 and the Wellington City Council Public Places Bylaw 2022.
