Traffic Resolution Plan TR76-21 Hill Street, Thorndon

Proposal to convert Coupon Parking to 24 P120 metered parks in lower Hill Street outside the Parliamentary Library

The respondents own two of the five apartments at the address known as 18-20 Hill Street.

One of the respondents is an Owner Occupier and has accurate daily knowledge of the Parking use in this specific area.

Resident Parking

Previously an Official Information request was made as to why this address is **not included** as able to apply and be granted a Resident Park.

The response was a thank you, as we are now aware there is further available parking we will review changing the area to Metered Parking without giving any specific reasons as to why the Residents of 18 – 20 Hill street could not apply for Resident Parking further up the street. There have always been spare resident parks available for which we have no access.

CBD vs Residential

That is, the council officer claimed that this address is CBD.

However, the address is deemed "Residential" by your own office as we do not have the benefits of CBD rubbish collection and must prepay for Residential Bags so therefore this is illogical and unfair. The rubbish collection is as per the weekly published rubbish collection cycle.

Parliamentary Precinct, not CBD

Furthermore, a recent property valuation by an Independent Registered Valuer described the Location as "being in the Parliamentary Precinct" that is, it is not in the CBD.

Retail

Further we note that apart from the Saint Paul's Saturday Market there are no Retail premises in Hill Street so it is unlikely shoppers that will have very little use for short term parking.

Special Character/Heritage

That Hill Street has a special Character and Heritage which will be damaged by further signs, pay machines and more traffic movement, having Churches, Schools and the British Consulate and Chinese Commercial Centre located in Hill street with Parliament as a neighbour.

Fiscal points

The 24 proposed parks are generally full with fee paying Coupon users who generally vacate around 6 pm weekdays and the parks have low use after this time so metered parking would not generate much revenue anyway for the proposed pay charges till 10pm at weeknights and all day up to 8pm on weekends.

The proposed substantial daily increase for coupon parking would provide the council with the increased revenue rather than interrupting the special character and current use of this small area. I note as published on Wednesday in a Stuff article, all the proposed changes are expected to bring in a small sum of two million dollars however this will further damage the retail/café/restaurant area diminishing the attractiveness of visiting the city and lowering spending.

PTO

The argument in the article goes on to state that the proposed increases will be higher than parking in Central London or Manhattan.

Weekend use

The weekend use is sporadic and sometimes unavailable due to Government, school, or Church events.

Available parking

It should be noted that both the Catholic Centre along with the Cathedral of the Sacred Heart and Saint Paul's Anglican Cathedral have available hundreds of covered and uncovered car parks as managed by Wilson Parking.

The predominant users of the current small number of coupon parks are Parliamentary or Governmental workers who do not disrupt the special character of this area as could happen with the higher movement of cars should Metered Parking be approved so by making these changes you will be losing all coupon revenue immediately and we believe that the revenue for the P120 will not recover this, because these current users will no longer be able to use these parks.

Safety of Nearby School Students and Security Concerns

This could also impact the safety of the hundreds of Students who use Hill Street to exit both Saint Mary's College and Sacred Heart Primary School being some 500 students along with the already congested Taxi Stand outside Saint Paul's where Taxis park over driveways etc awaiting fares.

This congestion on a busy street causing by queueing taxi and ongoing parking movements as proposed with increase the chances of accidents in the narrow street.

Also changing from somewhat managed Coupon Parking to random P120 directly outside Parliament may raise security concerns for Parliamentary Services.

In Conclusion

As owners or Residents of Hill Street who are unable to use the always available Resident parking we are further being penalised financially, and under Fairness and Natural Justice and common sense we would respectfully request immediate consideration to enable us to apply for Resident Parking which is readily available. At the OIA request photos were supplied showing the availability of Resident Parking at most times.

In a fiscal sense I cannot see substantial benefits for the council by even changing the current parking as there is every chance that hourly revenue will never meet 100% and indeed after 6pm any revenue would be extremely low along with the weekend's income.

Therefore, as stated in your proposal you would need constant enforcement to attempt to increase revenues which we believe will be the same/similar or lower as is currently being achieved without considering the costs of implementation as well as added concerns mentioned of safety, security, heritage, and lower use.
