## Summary

- Monorgan Road is major route for vehicle and pedestrian traffic
- Scots College is large school (approx. 1000 students)
- Peak-time issues with additional school traffic and buses
- Visibility and safety issues along road
- ... but there is no pedestrian crossing.

Our Residents Association strongly believe this needs to change and ask that the committee vote in favour of a pedestrian crossing being installed on Monorgan Road.
