- Create a true community representation honouring whenua at the Council against the airport.








## What we need from the Council?

- An acknowledgement there is an issue.
- An endorsement of the issue.
- The creation of a team or airport taskforce to engage and facilitate discussions with relevant parties (namely CAA, Airport and Aero Club) to address the issue.
- Consideration to implement By laws and rules in the District plan to minimize and contain these activities.



## What is a good outcome?

- Recreational air traffic is only allowed during certain time periods.
- Recreational air traffic is limited to a number of circles per day.
- Recreational air traffic can't fly over residential areas (e.g. further North, or over water).
- · Recreational air traffic becomes electric.
