### 1. 2 Apologies

#### 1. 3 Announcements by the Mayor

The Mayor made the following announcement:

"I want to congratulate our arts and cultural sector for its flexibility, durability and mutual support. The last 14 months have been very hard on many people, but particularly for those parts of our community which rely on gathering together, like arts and culture. In the last few days we've had the pleasure of attending a number of events including community based Kauri Theatre Company's hilarious production of Shortland Street at the Gryphon Theatre and the Wellington Opera Company's season of Don Giovanni at the Wellington Opera House. I particularly want to highlight Wellington Opera because it is a band new organisation, established through a lot of hard work – despite all the restrictions of the last year. The intent had been to perform Don Giovannni last August. I particularly want to pay tribute to Artistic Director Matthew Ross, and to Trust Chair Kerry Prendergast. While there are multiple funders of Wellington Opera, it is one of the many arts, culture and events activities that would not happen without Council's support. That is what we do. It's good for arts and culture, and good for activity in the heart of our city. To the best of our knowledge Wellington Opera is the only new opera company in the world since the arrival of COVID-19.

I am a strong believer in the local government family, and today I want to recognise that our family has just lost a special and significant member. Dave Cull sadly passed away this week. He was elected to Dunedin City Council in 2007, and served as Mayor of Dunedin from 2010 to 2019 – a period that included dealing with the financial impacts of the Forsyth Barr stadium and the Global Financial Crisis.

Dave became the head of our local government family. He was elected President of Local Government New Zealand in 2017, and stood down just a few months ago in August 2020. In

that role he championed among other things a coherent response to climate change. Before becoming Mayor, Dave was a TV presenter, mostly on home improvement, and an author of several books and contributor to many magazines. Those books included 'Icebergs The Antarctic Comes to Town' and 'Big Weather South Dunedin.'

I always enjoyed working with Dave. He was pragmatic, thoughtful, visionary, just a thoroughly decent bloke. We build on the shoulders of those who have gone before. There will be much that we build on Dave's shoulders.

I want to express my condolences to Dave's wife Joan, and his family and friends. I would appreciate it if you would stand with me for a few moments silence to recognise Dave Cull and his service to local government in New Zealand."

# 3.2 Report of the Strategy and Policy Committee Meeting of 8 April 2021 Mana Whenua Representation on Council Committees

#### Resolved

That the Council:

- 1. Agree to adopt the preferred option of appointing one representative from each of Taranaki Whānui ki Te Upoko o Te Ika and Ngāti Toa Rangatira to sit on all Council committees and subcommittees (except the CEO Performance Review Committee, noting that this also excludes Community Boards, the Appointment Group, and the District Licencing Committee) with full voting rights from 1 July 2021.
- 2. Agree to reimburse each of Taranaki Whānui ki Te Upoko o Te Ika and Ngāti Toa Rangatira for the contribution of their representatives as set out in recommendation 1 2 above, by paying each iwi an annual fee, equivalent to the remuneration of a full time elected member, which is currently \$111,225.
- 3. Note that while one person will be appointed to each committee and subcommittee from each of Taranaki Whānui ki Te Upoko o Te Ika and Ngāti Toa Rangatira, the relevant person nominated by iwi may be different for different committees / subcommittees.
- 4. Adopt the proposed changes to the Terms of Reference and Delegations for the 2019-22 Triennium (as adopted by Wellington City Council on 20 November 2019, latest update 20 January 2021) as is set out in Attachment 2.
- 5. Note that a number of actions will be undertaken by the Chief Executive in order to implement the above resolutions (which includes an agreement to be signed between Council and iwi and preparation of a declaration to be signed by the representatives).
- 6. Note that the representatives nominated by mana whenua for each committee and subcommittee will be brought to Council for endorsement and formal appointment to the relevant committee.
- 7. Agree that these resolutions relating to mana whenua representation on committees will endure until otherwise resolved by Council. This does not limit Council's ability to make changes to its overall committee structure (either at the next triennium or otherwise), including any external appointments.

Tēnā koe Mayor Foster,

We are writing in support of ensuring mana whenua included as paid members on Council committees. We are a national network of Mäori designers, architects, planners etc. who engage with local government entities across the country, mostly in the urban design and planning space. Our experience across the country suggest that mana whenua sidelined in democratic processes which favour an approach that privileges and gives voice to the majority. We suggest this is just one aspect of democracy and taken to its full conclusion results in an inequitable system that doesn't wholly respect the principles and obligations government hold as partners in Te Tiriti o Waitangi. The Tiriti offers mana whenua particular and unique rights as partners to the Crown for which local government is an agent.

The 2002 Local Government Act sets out Wellington City Council's obligations under the Treaty. Section 4 states:

In order to recognise and respect the Crown's responsibility to take appropriate account of the principles of the <u>Treaty of Waitangi</u> and to maintain and improve opportunities for Māori to contribute to local government decision-making processes, <u>Parts 2</u> and <u>6</u> provide principles and requirements for local authorities that are intended to facilitate participation by Māori in local authority decision-making processes. Supporting the inclusion and remuneration of mana whenua representatives on key Council committees then is a small step towards more fully responding to these obligations. We would encourage you and your fellow Councillors to vote for this motion.
