KiwiRail Holdings Limited ("**KiwiRail**") wishes to be a party to an appeal by Wellington International Airport Limited ("**WIAL**") against the decision of the Wellington City Council on the proposed Wellington District Plan ("**Proposed Plan**").

**Nature of interest**

1. KiwiRail made a submission on the Proposed Plan about the subject matter of the proceedings.
2. KiwiRail is not a trade competitor for the purposes of section 308C, 308CA or 308D of the RMA.

**Extent of interest**

3. KiwiRail is interested in that part of the proceedings which relates to Strategic Objective SCA-O6.

**Relief sought**

4. KiwiRail supports the relief sought by WIAL to retain the publicly notified version of SCA-O6 for the reasons set out in the WIAL appeal.
5. The relief sought by WIAL:
  - (a) will promote the sustainable management of natural and physical resources within Wellington City, and is therefore consistent with Part 2 and other provisions of the RMA;
  - (b) will meet the reasonably foreseeable needs of future generations;
  - (c) will enable the social, economic and cultural wellbeing of the people of Wellington;
  - (d) will facilitate the efficient use and development of natural and physical resources;
  - (e) will avoid, remedy or mitigate actual or potential adverse effects on the environment; and
  - (f) is the most appropriate way to achieve the objectives of the Proposed Plan in terms of section 32 of the RMA.

**Alternative dispute resolution**

6. KiwiRail agrees to participate in mediation or other alternative dispute resolution of the proceedings.
